(a) Amount Beneficially Owned: MFC Global has beneficial ownership of 3,750 shares of Common Stock, IIA has beneficial ownership of 878,100 shares of Common Stock and JHA has beneficial ownership of 140,900 shares of Common Stock. Through its parent-subsidiary relationship to MFC Global, IIA and JHA, MFC may be deemed to have beneficial ownership of these same shares.

(b) Percent of Class:

Of the 20,073,327 shares outstanding as of November 9, 2005 according to the issuer's quarterly report on form 10-Q for the period ended October 1, 2005, MFC Global held .001%, IIA held 4.4% and JHA held .7%.
