(a) and (b) Bonnie F. McCausland beneficially owned an aggregate of 10,227,437 shares of the issuer's Common Stock, or approximately 13.9% of the shares outstanding, as of December 31,2003, of which 398,264 shares were issuable upon exercise of stock options.

(c) Bonnie F. McCausland had sole power to vote or to direct the vote, and sole power to dispose or to direct the disposition of, 1,500 shares of the issuer's Common Stock. Mrs. McCausland had shared power to vote or to direct the vote, and/or shared power to dispose or to direct the disposition of, 10,225,937 shares of the Common Stock, which included 398,264 shares issuable upon exercise of stock options held by a trust for Mrs. McCausland's children of which Mrs. McCausland is a cotrustee, and 4,079 shares held by a charitable foundation (the "Foundation") of which Mrs. McCausland is an officer and director.
