The Reporting Person has acquired 13,758 shares of common stock of iStar Financial Inc. in settlement of vested common stock equivalent ("CSE") awards received by the Reporting Person, pursuant to the iStar Financial Inc. Non-Employee Directors' Deferral Plan ("Plan"). Under the Plan, the Reporting Person has received annual CSE awards effective as of the date of each annual meeting of shareholders beginning with the 2003 annual meeting. In addition, the Reporting Person has elected to have additional CSEs credited to his account in respect of dividend equivalent payments on his CSEs. In accordance with the Plan, the Reporting Person has elected to receive a distribution of his vested CSEs in the form of shares of iStar common stock.

Following this transaction, the Reporting Person beneficially owns a total of 368,790 shares of iStar common stock, consisting of 13,758 shares owned directly, 242,186 shares owned indirectly through a partnership and 112,846 shares owned indirectly through a family trust.
