On March 10, 2006, Casey's General Stores, Inc. (NASDAQ: CASY) reported February 2006 same-store sales results for stores open for one full year. Average gasoline gallons sold per store increased 4.7% in February 2006 compared to February 2005. The average retail price of gasoline sold during February 2006 was \$2.18 per gallon. Same-store sales of grocery and other merchandise increased 4.5% and prepared food and fountain same-store sales increased 8.7% in February 2006 compared to February 2005.
