**Item 7.01. Regulation FD Disclosure**

On October 16, 2006, Casey's General Stores, Inc. (the "Company") reported September 2006 same-store sales results for stores open for one full year. Same store gasoline gallons sold increased 6.7% in September 2006 compared to September 2005. The gasoline margin was in line with the Company's fiscal 2007 goal of 10.8 cents. The average retail price of gasoline sold during September 2006 was \$2.26 per gallon. Same-store sales of grocery and other merchandise increased 3.6% and prepared food and fountain same-store sales increased 17.0% in September 2006 compared to September 2005.
