Relevant Securities in Issue

ScottishPower announces, in accordance with Rule 2.10 of the City Code on Takeovers and Mergers, that as at the close of business on 8 March 2007 it had the following securities in issue:

Ordinary share capital 1,489,166,045 shares of 42p each ("ordinary shares").

The ISIN reference number for these securities is GB00B125RK88.

US\$ perpetual subordinated convertible bonds US\$700 million in aggregate ("convertible bonds"). The ISIN reference numbers for these securities are XS0171162075 (Reg S) and XS0171196727 (144a).

Dealing Disclosure Requirements

person is, or becomes "interested" (directly or indirectly) in 1% or more of any class of "relevant securities" of ScottishPower, all "dealings" in any "relevant securities" of that company (including by means of an option in respect of, or a derivative referenced to, any such "relevant securities") must be publicly disclosed by no later than 3.30pm (London time) on the London business day following the date of the relevant transaction. This requirement will continue until the date on which the offer becomes, or is declared, unconditional as to acceptances, lapses or is otherwise withdrawn or on which the "offer period" otherwise ends. If two or more persons act together pursuant to an agreement or understanding, whether formal or informal, to acquire an "interest" in "relevant securities" of ScottishPower, they will be deemed to be a single person for the purpose of Rule 8.3.

Under the provision of Rule 8.1 of the Code, all "dealings" in "relevant securities" of ScottishPower, or by any of their respective "associates", must be disclosed by no later than 12.00 noon (London time) on the London business day following the date of the relevant transaction.

A disclosure table, giving details of the companies in whose "relevant securities" "dealings" should be disclosed, and the number of such securities in issue, can be found on the Takeover Panel's website at <http://www.thetakeoverpanel.org.uk/>.

"Interests in securities" arise, in summary, when a person has long economic exposure, whether conditional or absolute, to changes in the price of securities. In particular, a person will be treated as having an "interest" by virtue of the ownership or control of securities, or by virtue of any option in respect of, or derivative referenced to securities.

Terms in quotation marks are defined in the Code, which can also be found on the Panel's website. If you are in any doubt as to whether or not you are required to disclose a "dealing" under Rule 8, you should consult the Panel.
