DEREGISTRATION OF UNSOLD SECURITIES

On June 21, 2006, the Securities and Exchange Commission (the "Commission") declared effective a registration statement on Form S-3 (File No. 333-134851) (the "Registration Statement") of Marchex, Inc. (the "Registrant") relating to the resale from time to time of up to 662,717 shares of Class B common stock of the Registrant (the "Registered Shares") by the selling shareholders named in the Registration Statement pursuant to the plan of distribution set forth therein.

The Registrant's obligation to keep the Registration Statement effective has terminated under the terms of its acquisition agreements with the selling stockholders. Pursuant to the undertaking of the Registrant as required by Item 512(a)(3) of Regulation S-K, the Registrant is filing this Post-Effective Amendment No. 1 to the Registration Statement to deregister all of its Registered Shares that remain unsold as of the date hereof. The Registration Statement is hereby amended, as appropriate, to reflect the deregistration of all such securities. The Registrant will cooperate with eligible holders to remove the restrictive legends from the Registered Shares.
