On July 19, 2012, Hubbell Incorporated (the Company ) reported net sales of \$778.4 million and earnings per diluted share of \$1.29 for the second quarter of 2012, as compared to net sales of \$709.2 million and earnings per diluted share of \$1.07 reported for the second quarter of 2011. The Company also reported net income of \$77.5 million for the second quarter of 2012, as compared to net income of \$65.2 million for the second quarter of 2011.
