This filing also reports in the ending balance of shares owned, the sum of 1,858.05 additional common shares acquired under the Company's Employee Share Purchase Plan (ESPP). The ESPP shares were purchased following the Reporting Person's last Section 16 filing. Under the ESPP 897.99 shares were acquired on September 8, 2016 at a transaction price of \$13.92 per share and 960.06 shares were acquired on December 8, 2016 at a transaction price of \$13.02. The ESPP provides for the purchase of fractional shares. The numbers reported herein are rounded to the nearest whole number.
