SIGNIFICANT EVENT

Today, TELEFÓNICA, S.A., through its wholly-owned subsidiary TELEFÓNICA EMISIONES, S.A.U., under its Guaranteed Euro Medium Term Note Programme (EMTN Programme) filed with the Financial Services Authority (FSA) in London on July 3rd, 2008, has increased the initial tranche of 1 billion euro of the Notes guaranteed by TELEFÓNICA, S.A. in the Euro market due April 1st, 2016 which was filed as significant event on March 1st, 2009 by a further 500 million euro.

This new 500 million euro Notes tranche pays an annual coupon of 5.496% and has a reoffer price of 103.214%. Settlement and closing date are scheduled for execution on June 3rd, 2009.
