- This Form 4 reports a disposition of Paired Shares to satisfy tax withholding obligations that occurred on March 15, 2016 and was inadvertently not previously reported. The effect of this error is that the number of directly held Paired Shares reported in Table I,
- (2) Column 5, in all subsequently filed Forms 4 prior to the date hereof was overstated by 2,971 shares. After giving effect to the disposition reported in this Form 4, the number of directly held Paired Shares beneficially owned by the reporting person as of the date hereof is 149,737.
