This amendment changes the vote required for the adoption of any proposal, other than the election of directors or matters that otherwise require a different vote under Delaware law or our Certificate of Incorporation, from a majority vote of the stockholders entitled to vote to the affirmative vote of a majority of votes cast, either in person or by proxy.
