DEREGISTRATION OF SECURITIES

This Post-Effective Amendment No. 1 (the "Post-Effective Amendment") relates to the Registration Statement on Form S-3 (Registration No. 333-59145) filed by McDonald's Corporation (the "Registrant") with the U.S. Securities and Exchange Commission on July 15, 1998 (the "Registration Statement") to register \$1,000,000,000 of the Registrant's Debt Securities. As of the date of this Post-Effective Amendment, approximately \$9,500,000 of the Debt Securities remain available for issuance by the Registrant.

In accordance with the Registrant's undertaking in Part II, Item 17(c) of the Registration Statement, the Registrant hereby amends the Registration Statement to remove from registration all securities registered but remaining unsold under the Registration Statement and to terminate the effectiveness of the Registration Statement.
