(1) This statement is being filed by The Goldman Sachs Group, Inc. ("GS Group" or the "Reporting Person"). The Reporting Person disclaims beneficial ownership of the securities reported herein except to the extent of its pecuniary interest therein, if any, and this statement shall not be deemed an admission that the Reporting Person is the beneficial owner of, or has any pecuniary interest in, such securities for purposes of Section 16 of the Exchange Act of 1934, as amended, or for any other purpose.

(2) Pursuant to an underwriting agreement, dated October 30, 2013, and in connection with the initial public offering of common stock, par value \$0.015 per share (the "Common Shares") of Essent Group Ltd. (the "Company") by the Company and its selling shareholders pursuant to the final prospectus dated October 30, 2013, which offering was consummated on November 5, 2013 (the "Initial Public Offering"), GS Group, as a selling shareholder, sold 1,510,118 Common Shares.

(3) As of November 5, 2013, as a result of the Initial Public Offering, GS Group may be deemed to beneficially own directly, in the aggregate, 6,038,745 of the Common Shares.

(4) Excludes 7,548,863 Common Shares beneficially owned by Commonwealth Annuity and Life Reinsurance Company Limited ("Commonwealth"). The Reporting Person disclaims both any pecuniary interest in any such Common Shares (and the Reporting Person will not report any transactions by Commonwealth in the Common Shares) and beneficial ownership of any such Common Shares for purposes of the calculation of greater than 10% beneficial ownership.
