Item 1. Security and Issuer.

This Amendment No. 33 (the Thirty-Third Amendment) amends the initial Schedule 13D (the Schedule 13D) filed with the Securities and Exchange Commission (the Commission), as subsequently amended, by the Reporting Persons (as defined below), with respect to the L Shares and A Shares of Teléfonos de México, S.A. de C.V. (the Issuer). Capitalized terms used but not otherwise defined in this Thirty-Third Amendment have the meanings ascribed to such terms in the Schedule 13D, as amended.

Item 2. Identity and Background.

This Statement is filed pursuant to Rule 13d-2(a) under the Securities Exchange Act of 1934, as amended (the Exchange Act), by the persons listed below (the Reporting Persons).

(1) Carlos Slim Helu, Carlos Slim Domit, Marco Antonio Slim Domit, Patrick Slim Domit, Maria Soumaya Slim Domit, Vanessa Paola Slim Domit and Johanna Monique Slim Domit (collectively, the Slim Family), each of whom is a Mexican citizen, beneficially own, directly and indirectly, a majority of the outstanding voting equity securities of Carso Global Telecom, S.A.B. de C.V. (CGT) and Grupo Financiero Inbursa, S.A.B. de C.V. (GFI). As a result, ownership of all L Shares and A Shares owned or controlled by these entities is deemed to be shared among each member of the Slim Family.

(2) GFI is a *sociedad anonima bursátil de capital variable* organized under the laws of Mexico. GFI is a financial services holding company. GFI owns all of the outstanding voting equity securities of several financial institutions organized in Mexico, including a broker-dealer, a bank, an insurance company and a surety bonding company. GFI also controls various trusts for the benefit of its employees, employees of its subsidiaries and employees of other entities that may be deemed to be controlled by the Slim Family.

(3) CGT is a *sociedad anonima bursátil de capital variable* organized under the laws of Mexico. CGT is a holding company with interests in the Issuer and other telecommunications companies.

(4) The Telmex Trust is a trust organized under the laws of Mexico as the pension plan for employees of the Issuer. Banco Inbursa S.A., Institucion de Banca Multiple, Grupo Financiero Inbursa, Division Fiduciaria, is the trustee of the Telmex Trust and a subsidiary of GFI. A technical committee, all of whose members are employees of the Issuer, makes investment decisions for the Telmex Trust. Thus, the Telmex Trust may be deemed to be controlled by the Issuer, which may be deemed to be controlled by CGT, and CGT and the Slim Family may be deemed to share beneficial ownership of all Shares beneficially owned by the Telmex Trust. CGT and the Slim Family expressly disclaim such beneficial ownership.

(6) The Telnor Trust is a trust organized under the laws of Mexico as the pension plan for employees of Telefonos del Noroeste, S.A. de C.V. (Telnor). Telnor is a wholly-owned subsidiary of the Issuer. Banco Inbursa, S.A., Institucion de Banca Multiple, Grupo Financiero Inbursa, Division Fiduciaria, is a trustee of the Telnor Trust and a subsidiary

of GFI. A technical committee, all of whose members are employees of the Issuer and Telnor, makes investment decisions for the Telnor Trust. Thus, the Telnor Trust may be deemed to be controlled by Telmex, which may be deemed to be controlled by CGT, and CGT and the Slim Family may be deemed to share beneficial ownership of all Shares beneficially owned by the Telnor Trust. CGT and the Slim Family expressly disclaim such beneficial ownership.

(7) Fundacion Telmex is a not-for-profit partnership organized under the laws of Mexico. A board, all of whose members are employees or directors of the Issuer, makes investment decisions for Fundacion Telmex. Thus, Fundacion Telmex may be deemed to be controlled by the Issuer, which may be deemed to be controlled by CGT, and CGT and the Slim Family may be deemed to share beneficial ownership of all Shares beneficially owned by Fundacion Telmex. CGT and the Slim Family expressly disclaim such beneficial ownership.

(8) Fundacion Carso is a not-for-profit partnership organized under the laws of Mexico. A board, the majority of whose members are members of the Slim Family, makes investment decisions for Fundacion Carso. Thus, Fundacion Carso may be deemed to be controlled by the Slim Family, and the Slim Family may be deemed to share beneficial ownership of all Shares beneficially owned by Fundacion Carso. The Slim Family expressly disclaims such beneficial ownership.

Updated information regarding the members of the Slim Family and the executive officers and directors of each of GFI, CGT, Fundación Telmex and Fundación Carso are set forth in Schedule I attached hereto. None of the Reporting Persons nor, to the best of their knowledge, any of the directors or executive officers listed in Schedule I has, during the last five years, been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors) or been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, Federal or State securities laws or finding any violation with respect to such laws.

Item 3. Source and Amount of Funds or Other Consideration.

The aggregate amount of funds required to purchase the 18,148,000 L Shares purchased by GFI since December 27, 2006 was U.S.\$25,578,391.61. The funds used to purchase these shares were obtained from the working capital of GFI.

The aggregate amount of funds required to purchase the 47,000,000 L Shares purchased by CGT through subsidiaries it controls since December 27, 2006 was U.S.\$68,368,407.40. The funds used to purchase these shares were obtained from the working capital of CGT.

(d) All A Shares and L Shares owned by trusts for the benefit of the Slim Family may be deemed to be beneficially owned by each member of the Slim Family that is a beneficiary of such trusts. Thus, beneficial ownership of A Shares and L Shares may be deemed to be shared by each member of the Slim Family. Because the Slim Family may be deemed to control, directly or indirectly, each of CGT, GFI and the Issuer, the Slim Family may be deemed to have the right to receive or the power to direct the receipt of dividends from, or the proceeds of the sale of, any A Shares or L Shares controlled by such persons (including the Telmex Trust, the Telnor Trust, Fundación Telmex and Fundación Carso). Except as disclosed herein, no person other than the Reporting Persons has or will have any right to receive or the power to direct the receipt of dividends from, or the proceeds of the sale of, A Shares or L Shares owned by the Reporting Persons.

(e) Not applicable.

CGT has entered into Forward Share Purchase Transactions pursuant to which it is obligated to buy L Shares (in the form of L Shares ADSs) from a counterparty on the terms specified below. The L Shares that are the subject of each contract listed below were sold to the counterparty at the inception of such contract, but for the purposes of this Statement are treated as beneficially owned by CGT. During the time that the shares are held by the counterparty, CGT pays interest to the counterparty on an amount equal to the total purchase price.
