The Advisor serves as investment manager to the Master Fund and several managed accounts (each a "managed account"). Mr. Edelman is the managing member of the Advisor.

(2) This transaction represents shares tendered in the initial tender offer commenced with respect to the Issuer's shares and related change in control of the Issuer at a price of \$4.50 per share plus contractual rights to receive up to an additional \$3.00 per share in contingent cash consideration payments.
