PRICE RANGE FOR INWIT'S INITIAL PUBLIC OFFERING

Minimum of EUR 3.25 per share, maximum of EUR 3.90 per share

Telecom Italia today announces that, subject to the necessary regulatory approvals from CONSOB, the price range of the initial public offering of shares in Infrastrutture Wireless Italiane S.p.A.'s (INWIT) has been set. The capitalization

was set in order to assess interest from institutional investors in relation to the global offering of INWIT's shares for the purpose of admission to trading on Italy's electronic share market (the "Global Offering").

Telecom Italia has set the price range, also on the basis of analysis conducted by the joint global coordinators of the Global Offering and in agreement with them, as between a non-binding minimum amount of EUR 1,950 million and a binding maximum amount of EUR 2,340 million, equal to a non-binding minimum price of EUR 3.25 per share of INWIT and a binding maximum price of EUR 3.90 per share of INWIT (i.e., the maximum offering price).

The information contained in this press release must not be relied upon to make any decisions to invest in the proposed public offering for sale. Prospective investors should only refer to the prospectus for any decision in relation to INWIT and the public offering of INWIT's shares. INWIT will publish the prospectus upon CONSOB's approval.
