The Form 10-Q for the quarter ended September 30, 2005 of Tower Automotive, Inc. (the Company) could not be filed by November 9, 2005 because the Company could not complete the preparation of the required information without unreasonable effort and expense. In conjunction with the gathering of information for the Form 10-Q, management identified a material weakness in the Company s internal control over financial reporting. As a result of this material weakness, material adjustments are necessary to present the condensed consolidated financial statements for the quarter ended September 30, 2005 in accordance with generally accepted accounting principles. This material weakness involved insufficient internal controls at one of the Company s North American manufacturing facilities. This material weakness is separate and unrelated to the material weaknesses in internal control over financial reporting disclosed in Part II, Item 9A of the Company s Form 10-K for the year ended December 31, 2004 and in Part I, Item 4 of the Company s Form 10-Q for the quarter ended June 30, 2005.

The Company expects to report a significantly higher net loss for the three months ended September 30, 2005 in comparison to the recognition of a net loss of approximately \$20.2 million for the three months ended September 30, 2004. The Company also expects to report a significantly higher net loss for the nine months ended September 30, 2005 in comparison to the recognition of a net loss of approximately \$10.9 million for the nine months ended September 30, 2004. The expected significant net losses for the 2005 periods relate primarily to restructuring charges, bankruptcy and related reorganization expenses and the recognition of income tax expense in the 2005 periods despite pre-tax losses.
