**The Registrant was unable to file its quarterly report on Form 10-Q in a timely manner without unreasonable effort or expense because management needs additional time to complete the financial disclosures in the report. The delay in management's completion of the financial disclosures is primarily due to the substantial workload borne by a relatively small accounting staff. The Registrant also experienced unexpected turnover of accounting personnel following the end of the third quarter and during the accounting staff's intense efforts to complete the Registrant's financial disclosures in the report. In addition, the Registrant's new accounting systems were not fully implemented and the Registrant's accounting staff was not adequately trained to utilize the systems. Finally, the Registrant's accounting staff expended substantial efforts in preparation for the Registrant's attempt to comply with Section 404 of the Sarbanes-Oxley Act of 2002.**

**Management has been working diligently to complete the financial disclosures and anticipates that the report will be filed no later than Monday, November 20, 2006.**

**Management is also working diligently to expand the Registrant's accounting staff, complete implementation of its new accounting systems and extensively train its accounting staff to utilize the systems to ensure the timely filing of future periodic reports without the necessity of a filing extension.**
