(1) Includes 4.296 shares of stock acquired through the reinvestment of dividends on June 30, 2005, at a price of \$56.5178 per share.

(2) The number of underlying securities is based on the stock fund balance on July 8, 2005. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a July 8, 2005 stock fund price of \$59.00 per share.

(3) The phantom stock units convert to the common stock's cash value on a one-for-one basis.

(4) The phantom stock units were accrued under the Johnson Controls Executive Incentive Compensation Plan and are to be settled 100% in cash upon the reporting person's retirement.
