(the "Common Stock") held by BPAM and 55,780 shares held Weiss Peck & Greer Investments, a division of Robeco USA, L.L.C. at December 31, 2005 for the discretionary accounts of certain clients. By reason of Rule 13d-3 under the Act, Investments, Robeco and BPAM may be deemed to be a "beneficial owner" of such Common Stock. To the knowledge of Robeco and BPAM, no person has the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, such Common Stock which represents more than 5% of the outstanding shares of the Common Stock referred to in Item 4(b) hereof.
