\*The aggregate percentage reported includes shares obtainable by the reporting person upon conversion of the convertible bonds in both shares beneficially owned and shares outstanding rather than, as in the December 10, 2013 filing, only in shares beneficially owned. Without this inadvertent omission a 13G filing would not have been required and would not have been made.

Telecom Italia has provided in the Trust Deed for the convertible bonds that if it does not have a sufficient number of shares for a complete exercise of the conversion right by bond holders, the convertible bonds may instead be settled in a combination of shares and cash. Telecom Italia shareholders will vote on authorizing additional shares at a shareholder meeting to be held on December 20, 2013. The number of shares disclosed herein as beneficially owned by the reporting person presumes the reporting person's exercise in full of all of its rights to acquire shares that may be exercised within 60 days, regardless of the possibility that Telecom Italia may not have a sufficient number of shares.

In addition, the number of shares as to which the reporting person has sole voting power has been modified to reflect that certain accounts retain full voting power over securities held by the reporting person.
