Long Position

Portugal Telecom, SGPS S.A. (PT) informs that it was notified of the following regarding the long position held by Barclays Plc:

A) Change in the composition of interest (dated 22 November 2011)

On 22 November 2011, there was a change in the composition of Barclays Plc's long position in PT as a result of the expiry of a forward contract equal to 3,335,000 PT shares, which was held by Barclays Capital Securities Ltd and the acquisition, also by Barclays Capital Securities Ltd, of 3,335,000 PT shares. Barclays Plc's overall long position in PT remained above the 2% threshold of reportable interests as was previously disclosed.
