**MTS Repurchases Series 03 Ruble Bond**

18 December 2014

**Moscow, Russian Federation Mobile TeleSystems OJSC ( MTS or the Company NYSE: MBT), the leading telecommunications provider in Russia and the CIS, announces the repurchase of the Series 03 ruble bond in the amount of RUB 3.71 billion.**

**The RUB 10 billion series 03 ruble-denominated bond with maturity on June 12, 2018 and a two-year put option was issued on June 24, 2008. The coupon was to be paid semi-annually at the rate of 8.70% for the 1st-4th coupons and at the rate of 8.00% for 5th-10th coupons. On June 05, 2013, the Company changed the coupon rate for the 11th coupon to 7.00% with a six-month put option. On December 09, 2013, the Company changed the coupon rate for the 12th and 13th coupons from 7.00% to 7.50% with a one- year put option. On December 05, 2014, MTS changed the coupon rate for the 14th and 15th coupons from 7.50% to 12.00% with a one-year put option.**

**The bond is part of the Level 1 quotation list on the Moscow Exchange.**

**Gazprombank, the Lead Arranger of the Bond, acted as the Repurchase Agent.**
