On November 19, 2004 (the "Effective Date"), the merger between Gristede's Acquisition Corp. ("GAC") and Gristede's Foods, Inc. (the "Company"), pursuant to an Agreement and Plan of Merger dated September 10, 2004, became effective with the Company being the surviving corporation. Pursuant to this transaction, each share of the Company's common stock, \$.02 par value per share, outstanding on the Effective Date was converted into the right to receive \$.87

per share in cash, without interest, except for shares held by (a) GAC, which shares were cancelled in the merger transaction or (b) dissenting stockholders who perfect their dissenter's rights under Delaware Law. As a result of this transaction, the Company will no longer be listed on the American Stock Exchange.
