Grant of restricted share units (RSUs) which vests in three equal portions on February 3, 2016, 2017, and 2018. RSU holders are entitled to receive dividend equivalents, exempt from line item reporting under SEC Rule 16a-11, to the same extent dividends are paid on common shares.
