The RSUs are scheduled to vest, subject to continued employment, as follows; 11,236 shares on each of November 11, 2015 and November 11, 2016, 30,484 shares on July 16, 2017, 10,162 shares on July 16, 2018 and 10,160 shares on July 16, 2019.
- (2) On April 9, 2015, Starbucks Corporation effected a 2-for-1 stock split. The number of shares reported throughout this Form 4 have been adjusted to reflect the stock split.
