(1) Represents shares to satisfy withholding tax obligation for Restricted Stock vesting.

On March 29, 2018, the reporting person was granted performance restricted stock units ("PSUs") that vest in three equal installments contingent on FIS's satisfaction of certain performance criteria for each of the calendar years ending December 31, 2018, 2019 and 2020.

(2) The PSUs vest between 0% and 150% of the target grant amount in each year. The Compensation Committee of FIS determined that the maximum performance criteria for 2018 had been met, resulting in an award of 150% of the target grant amount.

(3) Represents shares to satisfy withholding tax obligation for PSU vesting.

(4) Represents shares to satisfy withholding tax obligation for Restricted Stock Unit vesting.

(5) Each restricted stock unit represents a contingent right to receive one share of FIS common stock.

(6) The restricted stock units vest and distribute in three equal annual installments commencing on the first anniversary date of the grant.

On March 29, 2016, the reporting person was granted an option to purchase 22,633 shares of common stock. The option vests in three equal installments based on FIS's satisfaction of certain performance criteria for each of the calendar years ending December 31, 2016, 2017 and 2018. Based on FIS's Annual Report on Form 10-K, the Compensation Committee of FIS determined that the performance criteria for 2018 had been met, resulting in vesting of the option as to 7,545 shares.

On March 29, 2017, the reporting person was granted an option to purchase 39,277 shares of common stock. The option vests in three equal installments based on FIS's satisfaction of certain performance criteria for each of the calendar years ending December 31, 2017, 2018 and 2019. Based on FIS's Annual Report on Form 10-K, the Compensation Committee of FIS determined that the performance criteria for 2018 had been met, resulting in vesting of the option as to 13,092 shares.

(8) The option vests in three equal annual installments commencing on the first anniversary date of the grant.
