A press release was issued in Toronto, Ontario on June 7, 2006 by Filing Services Canada under section 7.1 of National Instrument 51-102 re: publication of material change.

Summary of Material Change

On June 7, 2006 the Company closed an arm's length private placement of 7,500,000 Common Shares of the Company to a group of institutional and private investors at a purchase price of CAD \$1.21 per share, yielding gross proceeds of CAD\$ 9,075,000.

Item 5.

Full Description of Material Change

On June 7, 2006, the Company closed an arm's length private placement of 7.5 million of the Company's Common Shares to a group of institutional and private investors at a purchase price of CAD\$1.21 per share, yielding gross

proceeds of CAD\$ 9,075,000. Westwind Partners Inc. acted as sole agent to Peace Arch in Canada.

The offering remains subject to final regulatory approval. The net proceeds of the offering will be used by Peace Arch to fund working capital requirements and to repay the interim debt financing the Company incurred in connection with its recent acquisition of leading Canadian home entertainment distributor kaBOOM! Entertainment Inc. Further details on the kaBOOM acquisition are as set out in the press release dated January 24, 2006.

All securities will be subject to a four month hold period in accordance with applicable Canadian securities law and the policies of the Toronto Stock Exchange. The securities offered have not been registered under the United States Securities Act of 1933, as amended, and may not be offered or sold in the United States absent registration or an applicable exemption from the registration requirements.
