This Time-Based Restricted Stock Unit award vests in full on the fourth anniversary of the Grant Date, provided the Grantee is then employed by the Company or an Affiliate. This is an equity inducement award pursuant to the corporate governance rules of the New York Stock Exchange.

(2) Represents the award of Time-Based Restricted Stock Units that convert to common stock on a one-for-one basis. This Time-Based Restricted Stock Unit award vests in equal one-third increments on each of the first three (3) anniversaries of the Grant Date provided the Grantee is then employed by the Company or an Affiliate.
