- Richard C. Breeden is the managing member of Breeden Capital Partners LLC and the managing member and chairman and chief executive officer of Breeden Capital Management LLC. Breeden Capital Partners LLC is in turn the general partner of Breeden Partners L.P. and Breeden Partners (California) L.P. (the "California Fund" and, collectively with Breeden Partners L.P., the "Funds").
- On February 7, 2013, the Issuer granted 951 shares of common stock of the Issuer (the "Common Stock") to Mr. Breeden as compensation for services rendered as a director of the Issuer. Pursuant to the governing documents of the Funds, any economic interests realized with respect to these shares will be apportioned among the Funds.
- Mr. Breeden continues to hold of record 17,781 shares of Common Stock directly. Pursuant to the governing documents of the Funds, any economic interests realized with respect to these shares will be apportioned among the Funds.
- Pursuant to Rule 16a-1(a)(2)(ii)(B) of the Securities Exchange Act of 1934, as amended, Mr. Breeden in his capacity as managing member, as well as chairman and chief executive officer of Breeden Capital Management LLC and as the managing member of Breeden Capital Partners LLC, may be deemed to be the indirect beneficial owner of the shares of Common Stock owned by the Funds; however, he disclaims beneficial ownership of such shares except to the extent of his pecuniary interest therein.
