Based on the closing price of the Common Stock on NASDAQ on July 1, 2015 of \$15.96 per share, a total of 148 shares were purchased for Mr. Goldstein on July 1, 2015.
- (2) As a principal member and member of the investment committee of CapGen Capital Group III LLC ("CapGen LLC"), the general partner of CapGen Capital Group III LP ("CapGen III"), Mr. Goldstein may be deemed to be the indirect beneficial owner of such shares under Rule 16a-1(a)(2) promulgated under the Exchange Act. Pursuant to Rule 16a-1(a)(4) promulgated under the Exchange Act, Mr. Goldstein disclaims that he is the beneficial owner of such shares, except to the extent of his pecuniary interest.
