Biddle (the "Reporting Person"), whereby Mr. Biddle was granted a restricted stock award of 2,500 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (2) This figure includes 32,500 restricted shares of Class A Common Stock issued to Mr. Biddle pursuant to the Restricted Award Plan. On January 3, 2017, restrictions applicable to a previously reported grant of 5,000 shares of Class A Common Stock lapsed, resulting in Mr. Biddle becoming fully vested in such shares.
