Mr. Kolchinsky is the manager of Capital and therefore may be deemed a beneficial owner, for purposes of Section 13(d) of the Act, of any securities of the Issuer beneficially owned by Capital. Capital is a registered investment adviser within the meaning of Rule 13d-1(b)(1)(ii)(E), and Mr. Kolchinsky is a control person of Capital within the meaning of Rule 13d-1(b)(1)(ii)(G). Capital and Mr. Kolchinsky disclaim beneficial ownership of the securities reported above other than for the purpose of determining their obligations under Section 13(d) of the Act, and the filing of this Amendment shall not be deemed an admission that either Capital or Mr. Kolchinsky is the beneficial owner of such securities for any other purpose. Shares reported herein for the Fund represent shares of Common Stock (i) held of record by the Fund and (ii) issuable upon exercise of call options held of record by the Fund. Shares reported herein for RA Capital represent (a) the shares of Common Stock reported for the Fund and (b) shares of Common Stock (I) held in the Account and (II) issuable upon exercise of call options held in the Account.
