#### Super Short-term Commercial Paper

The Company and all members of the Board warrant that the information set out in this announcement is true, accurate and complete, and accept joint responsibility for any false information or misleading statements contained in, or material omissions from, this announcement.

On 25 March 2016, China Eastern Airlines Corporation Limited (the "**Company**") received the Notice of Acceptance of Registration (Zhong Shi Xie Zhu [2016] No. SCP64) issued by the National Association of Financial Market Institutional Investors (the "Association") to allow the Company to issue super short-term commercial papers with a total registered amount of RMB20 billion. The registration amount is valid for a term of two years from the date of issue of the notice. The super short-term commercial papers may be issued in tranches within the effective term of registration.

The Company completed the issuance of the 2016 fifth tranche of super short-term commercial papers (the "**2016 Fifth Tranche SCP**") within the aforesaid registration amount on 13 April 2016. The issuance amount of the 2016 Fifth Tranche SCP was RMB3.0 billion with a maturity of 90 days whereas the nominal value was RMB100 per unit and the annual interest rate was 2.35%.

Bank of Beijing Company Limited and Bank of Communication Limited, acting as the joint lead underwriters, formed an underwriting syndicate for the 2016 Fifth Tranche SCP. The 2016 Fifth Tranche SCP will be issued to institutional investors in public in the PRC interbank debenture market by way of book-building and centralised placing. The proceeds from the 2016 Fifth Tranche SCP will be used principally to re-finance bank loans of the Company and to improve the debt structure of the Company.
