Mr. Silver has the sole voting and dispositive power with respect to 651,373 shares of Common Stock held by Mr. Silver, Sherleigh Associates Inc. Profit Sharing Plan, Silver Investment Partners LP, Romleigh LLC, Silver Family 2007 Limited Partnership and Lena June Enterprises LC.
