Mr. Kanen, as the managing member of Kanen Wealth Management LLC ("KWM"), may be deemed to beneficially own the 2,198,116 shares of Common Stock held in customer accounts managed by KWM (including the 18,921 shares held (1) in Mr. Kanen's account) and the 1,810,000 shares of Common Stock held by The Philotimo Fund LLC, of which KWM is the general partner. Mr. Kanen expressly disclaims such beneficial ownership except to the extent of his pecuniary interest therein. Mr. Kanen does not have a pecuniary interest in the shares of Common Stock held in customer accounts managed by KWM other than the shares held in Mr. Kanen's account.
