As of December 31, 2012, John T. Hewitt (the "Reporting Person") beneficially owned 2,416,722 shares of Class A Common Stock of the Issuer (the "Shares"), representing approximately 16.8% of the total Shares outstanding. This percentage of Shares is based upon 12,094,896 Shares outstanding as of November 30, 2012, as reported in the Quarterly Report on Form 10-Q for the period ended October 31, 2012, filed by the Issuer with the U.S. Securities and Exchange Commission (the "SEC") on December 4, 2012.

Between December 31, 2012 and December 31, 2016, the Reporting Person's beneficial ownership increased as result of Shares awarded as compensation, as reported by the Reporting Person's filings pursuant to Section 16 of the Securities Exchange Act of 1934. As of December 31, 2016, the Reporting Person beneficially owned 2,352,302 Shares, representing approximately 16.5% of the total Shares outstanding. This percentage of Shares is based upon 12,710,831 Shares outstanding as of November 30, 2016, as reported in the Quarterly Report on Form 10-Q for the period ended October 31, 2016, filed by the Issuer with the SEC on December 9, 2016.
