- (1) with and into Fidelity National Information Services, Inc. ("FIS") (the "Merger"). On the effective date of the Merger, the closing price of FNF's common stock was \$21.24 per share, and the closing price of FIS's common stock was \$41.35 per share.
- (2) Shares represent aggregate holdings of THL FNIS Holdings LLC, Thomas H. Lee Equity (Cayman) Fund V, L.P. ("Cayman Fund") and Thomas H. Lee Investors Limited Partnership ("Investors"). THL FNIS Holdings LLC is wholly owned by Thomas H. Lee Parallel Fund V, L.P. and Thomas H. Lee Equity Fund V, L.P. (the "Funds"). The general partner of the Funds and Cayman Fund is THL Equity

Advisors V, LLC, which, in turn, is wholly owned by Thomas H. Lee Partners, L.P. The reporting person is a Managing Director of Thomas H. Lee Partners, L.P. The general partner of Investors is THL Investment Management Corp. The reporting person is a Vice President of THL Investment Management Corp. As such, the reporting person may be deemed to beneficially own the shares of the Issuer owned directly by each of the Funds, Cayman Fund and Investors.

- The reporting person disclaims beneficial ownership of such shares, and this report shall not be deemed an admission that the reporting person is the beneficial owner of the securities for the purpose of Section 16 or for any other purpose, except to the extent of its pecuniary interest therein.
- (3) The option vests in three equal annual installments beginning August 19, 2006, prior to the exchange, as noted in footnote 4.
