- (1) These are restricted shares that were issued under the Director Fee Program of the Amended and Restated 1993 Stock Option/Stock Issuance Plan at the election of Mr. Sabin. The shares vest in 25% increments at the end of each quarter during 2008.  
The 3,515 restricted shares were issued in the name of GSSW-REO, LLC, for which Mr. Sabin serves as Manager and Vice President.
- (2) Although Mr. Sabin is reported as the beneficial owner of these shares, he disclaims beneficial ownership in these shares as he has no pecuniary interest in them.
- (3) Includes 275,930 shares held by GSSW-REO, LLC and the newly awarded 3,515 restricted shares held by GSSW-REO, LLC, for which Mr. Sabin serves as Manager and Vice President. Although Mr. Sabin is reported as the beneficial owner of the 283,445 shares, he disclaims beneficial ownership in these shares as he has no pecuniary interest in them.
