 - (7) The RSUs, which include an aggregate of 46.2514 Dividend Units, vest in four equal annual installments beginning on November 14, 2017.
 - (8) Date indicated is date of grant. Option vests in four equal annual installments beginning on the first anniversary of the date of grant.
