  - (2) A Restricted Stock Unit, which is issued under the Company's 1989 Stock Awards Plan, is a right to receive one share of common stock of the Issuer in the future, subject to the terms and conditions of the award agreement. The units vest annually, on a prorata basis, over a

five-year period beginning on the first anniversary of the date of grant, subject to certain accelerated vesting provisions.

- (3) The reporting person has received Restricted Stock Units, which are issued under the Company's 1989 Stock Awards Plan, and is a right to receive one share of common stock of the Issuer in the future, subject to the terms and conditions of the award agreement. The units will vest on November 1, 2012, five years from the reporting person's date of employment, pursuant to the terms of his letter offering employment.
