(1) These shares were sold pursuant to a Rule 10b5-1 plan that was disclosed by my Form 144 filed on 1/7/2005.

This total does not include 7,534 shares held indirectly through family trusts for which I have voting and investment control. I have a power of attorney for 6,000 shares owned by father for which I have investment and voting control. I disclaim any economic interest in these shares or in the shares held through family trusts.

(4) May 1, 2004-2006.

This total includes 24,895.1614 phantom stock units held in an excess benefits plan. It also includes phantom stock units attributable to deferred director's fees. I began receiving cash payments for the value of phantom stock units (exclusive of deferral director's fees) effective May 1, 2003. I began receiving annual cash payments for the value of my phantom stock units attributable to deferred director's fees effective May 1, 2004.
