- (1) Pursuant to the Underwriting Agreement between Deutsche Bank Securities Inc., as representative of the underwriters, and the Issuer, a form of which was attached as Exhibit 1.1 to Amendment No. 2 to the Registration Statement on form S-1, filed by the Issuer on October 9, 2007, the Issuer was obligated to repurchase certain founders shares issued to Peckslad Partners, LLC to reflect the partial non-exercise of the underwriters' over-allotment option.
- (2) After giving effect to the redemption, Peckslad Partners, LLC beneficially owns 3,964,844 shares of common stock of the Issuer. Mr. Litt owns membership interests representing approximately 22.46% of the outstanding equity interests of Peckslad Partners, LLC, both directly and indirectly through a family trust. Mr. Litt hereby disclaims beneficial ownership of the shares of common stock held by Peckslad Partners, LLC in excess of the proportion that can be imputed to his fractional ownership of equity interests in Peckslad Partners, LLC.
