On May 27, 2008, First Data Corporation (the "Company") and JPMorgan Chase announced that they had agreed to end the Company's largest merchant alliance, Chase Payment Solutions, LLC (the "Alliance"), by the end of 2008. Under the agreement, the Company will receive assets and other consideration equivalent to our 49% interest in the Alliance.
