- (1) On September 19, 2006, Mr. Wallace received a grant of restricted stock units ("RSUs") covering shares of KLA-Tencor Corporation common stock. Following the completion of KLA-Tencor's fiscal year 2007, KLA-Tencor's Board of Directors determined that the number of shares of KLA-Tencor common stock subject to such RSU grant was 62,500. On September 19, 2008, Mr. Wallace vested in fifty percent (50%) of such RSUs.
 - (2) Pursuant to the terms of the September 19, 2006 RSU grant, 12,458 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding.
 - (3) Each RSU represents a contingent right to receive one share of KLA-Tencor common stock.
