(1) Andrew Balson is a Managing Director of Bain Capital Investors, LLC ("BCI"), which is the administrative member of Bain Capital Integral Investors 2006, LLC ("BC Integral"). As a result, Mr. Balson may be deemed to share voting and dispositive power with respect to the shares of Common Stock held by BC Integral. Mr. Balson disclaims beneficial ownership of such securities except to the extent of his pecuniary interest therein. On April 4, 2012, BC Integral sold 8,896,328 shares of Common Stock. Following such sale, BC Integral held 12,126,832 shares of Common Stock.

(2) BCI is the administrative member of BCIP TCVC, LLC ("BCIP TCVC"). As a result, Mr. Balson may be deemed to share voting and dispositive power with respect to the shares of Common Stock held by BCIP TCVC. Mr. Balson disclaims beneficial ownership of such securities except to the extent of his pecuniary interest therein. On April 4, 2012, BCIP TCVC sold 90,901 shares of Common Stock. Following such sale, BCIP TCVC held 112,273 shares of Common Stock.

(3) BCI is the managing general partner BCIP Associates-G ("BCIP G"). As a result, Mr. Balson may be deemed to share voting and dispositive power with respect to the shares of Common Stock held by BCIP G. Mr. Balson disclaims beneficial ownership of such securities except to the extent of his pecuniary interest therein. On April 4, 2012 BCIP sold 2,840 shares of Common Stock. Following such sale, BCIP G held 3,508 shares of Common Stock.
