- (1) Grant of restricted stock under the 2007 Omnibus Plan pursuant to employment agreement dated March 9, 2012 and letter agreement effective May 8, 2012. Of the 15,000 total shares to be awarded to Mr. Keown pursuant to the employment agreement, 8,170 shares were granted on May 11, 2012 (the "May Grant") and reported on a Form 4 filed with the SEC on May 14, 2012. The remaining 6,830 shares were granted on September 12, 2012 (the "September Grant") and are being reported on this Form 4.
