- (1) On June 19, 2012, the reporting person was granted 15,435 shares of restricted stock, subject to the achievement by the Company of performance vesting criteria based on the Company's average return on equity measured at the end of fiscal 2013. On May 3, 2013, the performance vesting criteria was determined to have been met such that 15,435 shares of restricted stock have been earned. In accordance with the Restricted Stock Agreement, the restrictions on one-fifth of the earned shares (3,087 shares) will lapse on June 19, 2013. The restrictions on the remaining shares will lapse ratably on March 31 of 2014, 2015, 2016, and 2017.
