On October 14, 2013, First Data Corporation (the "Company") issued a press release to announce that its parent company, First Data Holdings Inc. (formerly known as New Omaha Holdings Corporation) has reached an agreement with existing debt holders to repay a portion of the approximately \$2 billion 11.5% senior payable-in-kind ("PIK") notes due 2016 and exchange the remainder for new 14.5% senior PIK notes due 2019.
